Prerequisites for the Issue of the Certificates according to AQAP 2310/2210 by BAAINBw

The issue of the certificates (initial and follow-up certificates) according to AQAP 2310/2210 by branch ZtQ1.1 of the BAAINBw directorate Technical Quality Assurance Centre (ZtQ) requires and has to be fulfilled the following:

- a contractor's request for (re)confirmation of their quality management system (QMS) according to AQAP 2310/2210
- at least one current design or production contract or subcontract with agreed GQA (Government Quality Assurance), which will be carried out by GQA-offices of BAAINBw ZtQ. The certified company has to inform BAAINBw ZtQ1.1 immediately if it is foreseeable, that there will be no contract in the following twelve months.
- a valid certificate according to ISO 9001 or EN 9100 issued by an accredited certification body
- successful inspection of the QMS by a GQA-office of BAAINBw ZtQ regarding NATO Supplements of AQAP 2310/2210, taking into account concrete experiences the responsible GQA-office gained during the contract realization.
- The contractor confirms to inform BAAINBw ZtQ1.1 about fundamental modifications of QMS before the implementation of this modifications starts

Validity of the Certificate according to AQAP 2310/2210

The period of validity of the issued AQAP-certificates generally depends on the life of the corresponding ISO 9001 or EN 9100 certificates.

The issued certificate according to AQAP 2310/2210 will lose its validity if:

- the contractor's QMS according to AQAP 2310/2210 is not applied effectively/ not maintained any longer
- changes to the contractor's QMS have adverse effects on the fulfilment of the NATO Supplements to AQAP 2310/2210 and if these are not acceptable to the competent authority (BAAINBw section ZtQ1.1)
